 - b. References to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this privacy policy;
 - c. A reference to a person includes firms, companies, government entities, trusts and partnerships;
 - d. "Including" is understood to mean "including without limitation";
 - e. Reference to any statutory provision includes any modification or amendment of it;
 - f. The headings and sub-headings do not form part of this privacy policy.

Scope of this privacy policy

- 3. This privacy policy applies only to the actions of Findmeacaterer Private limited and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.
- 4. For purposes of the applicable Data Protection Laws, Findmeacaterer Private limited is the "data controller". This means that Findmeacaterer Private limited determines the purposes for which, and the manner in which, your Data is processed.

Data collected

- 5. We may collect the following Data, which includes personal Data, from you:

- 1. In each case, in accordance with this privacy policy.

How we collect Data

- 6. We collect Data in the following ways:
 - a. Data is given to us by you;
 - b. Data is received from other sources; and
 - c. Data is collected automatically.

Data that is given to us by you

- 7. Findmeacaterer Private limited will collect your Data in a number of ways, for example:
 - a. when you contact us through the Website, by telephone, post, e-mail or through any other means;
 - b. when you register with us and set up an account to receive our products/services;
 - c. when you make payments to us, through this Website or otherwise;
 - d. when you elect to receive marketing communications from us;
 - e. when you use our services;

in each case, in accordance with this privacy policy.

Data that is received from third parties

- 8. Findmeacaterer Private limited will receive Data about you from the following third parties:

Data that is collected automatically

- 10. To the extent that you access the Website, we will collect your Data automatically, for example:
 - a. We automatically collect some information about your visit to the Website. Our use of Data

- 12. We may use your Data for the above purposes if we deem it necessary to do so for our legitimate interests. If you are not satisfied with this, you have the right to object in certain circumstances (see the section headed "Your rights" below).
- 13. For the delivery of direct marketing to you via e-mail, we'll need your consent, whether via an opt-in or soft-opt-in:
 - a. Soft opt-in consent is a specific type of consent which applies when you have previously engaged with us (for example, you contact us to ask us for more details about a particular product/service, and we are marketing similar products/services). Under "soft opt-in" consent, we will take your consent as given unless you opt-out.

Who we share Data with

- 16. We may share your Data with the following groups of people for the following reasons:

 - d. Third party payment providers who process payments made over the Website to enable third party payment providers to process user payments and refunds;

in each case, in accordance with this privacy policy.

Keeping Data secure

- 17. We will use technical and organisational measures to safeguard your Data, for example:
 - a. Access to your account is controlled by a password and a user name that is unique to you.
 - b. we store your Data on secure servers.

Data retention

- 21. Even if we delete your Data, it may persist on backup or archival media for legal, tax or regulatory purposes.



Your rights

- 22. You have the following rights in relation to your Data:
 - a. Right to access the right to request
 - (i) copies of the information we hold about you at any time, or
 - (ii) that we modify, update or delete such information. If we provide you with access to the information, we hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive." Where we are legally permitted to do so, we may refuse your request. If we refuse your request, we will tell you the reasons why.
 - b. Right to correct the right to have your Data rectified if it is inaccurate or incomplete.
 - c. Right to erase the right to request that we delete or remove your Data from our systems.
 - d. **Right to restrict our use of your Data** the right to "block" us from using your Data or limit the way in which we can use it.
 - e. Right to data portability the right to request that we move, copy or transfer your Data.
 - f. **Right to object** the right to object to our use of your Data including where we use it for our legitimate interests.
